

## ADDITIONAL EXEMPTION APPLICATION

Clearly place an X by the exemption(s) that you qualify for, complete bottom portion, and attach required documentation.

- ☐ **LOW INCOME SENIOR**- Reduces taxable value by up to \$25,000 for county taxes  
Must be 65 years of age as of January 1, 2026 with a total **household** income of no more than \$38,686. This includes the income of anyone who lives with you. **Required documentation:** a copy of your 2025 Federal Income Tax Return or IF you DO NOT file a Tax Return, submit a Low-Income Senior Affidavit\*

- ☐ **WIDOW/WIDOWER**- Reduces taxable value by \$5,000  
Cannot be divorced prior to death. **Required documentation:** a xerox or scanned copy of death certificate

- ☐ **DISABILITY**- Reduces taxable value by \$5,000  
Must be certified as totally and permanently disabled, but not requiring the use of a wheelchair for mobility. **Required documentation:** a Florida Physician's certification form DR-416\*

- ☐ **LEGALLY BLIND**- Reduces taxable value by \$5,000  
**Required documentation:** a Florida Physician's certification form DR-416 or DR-416B\*

Persons who are legally blind or confined permanently to a wheelchair, paraplegic, hemiplegic AND have a low income may be eligible for additional savings. **Please contact our office at 407-665-7512 to learn more about the qualifications and how to apply.**

- ☐ **SERVICE – CONNECTED DISABLED VETERAN**- Reduces taxable value by \$5,000\*\*  
**Required documentation:** a copy of the VA Disability award letter reflecting a "service-connected disability of (designated %)". \*The un-remarried surviving spouse of such disabled ex-service member is also entitled to the exemption, please contact our office at 407-665-7512 for more information.
- ☐ **65+ YEAR OLD VETERAN, SERVICE-CONNECTED COMBAT RELATED**- Percentage discount  
**Required documentation:** copy of DD Form 214 and VA Disability award letter reflecting a "combat related service-connected disability of (designated %)".

\*\*Any honorably discharged veteran or their surviving spouse with a **service-connected total and permanent disability** is entitled to a 100% exemption. **Please contact our office at 407-665-7512 to learn more about the qualifications and how to apply.**
